1. THAT I HEREBY RELEASE AND HOLD HARMLESS WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY NEGLIGENCE OR OTHERWISE, O.C. PAINTBALL AND SPORTS CENTER INC. and SANFORD & SON-IN-LAW LLC, herein referred to as releasees.
